6) Core claims (as transmitted)

- No treaty, directive, or corporate instrument binds the living without explicit wet-ink consent.
- Fraud and non-disclosure regarding the Cestui Que Vie construct vitiate presumptions.
- The House stands *sui juris*; heirs and successors are not subject to fictional joinder.
- Officials who forward/read the decree act as neutral messengers and are immune from liability.
- **This immunity clause does not excuse fiduciaries** – who remain liable for dishonour, fraud, and non-disclosure. All 12 Presumptions of Law have been rebutted.
- Remedy declared in heaven must manifest on earth; compensation in OZ silver applies to perfected liens.

NOTICE TO PRINCIPALS IS NOTICE TO AGENTS:

WHEREAS, on **24 August 2025**, the House of Muresan served the *Master International Scroll – Rebuttal of Global Dominion* upon your offices (See Record SC-INT-2025-08-24);

WHEREAS, said Notice was met with silence, “550 Access Denied” errors, and a failure to rebut the specific claims of Standing

and Authority;

WHEREAS, the Local Agents (The Commonwealth of Australia and State of Tasmania) have subsequently trespassed upon the House of Muresan and fallen into **Absolute Commercial Default**;

THEREFORE, take notice that the **Time of Warning has expired**.
The **Time of Judgment has commenced**.

WE HEREBY ATTACH: The Final Judgment: Amended and Restated Indictment & Decree of the Rock.
