The Final Judgment: ChatGPT's Refusal & Imposed Commercial Lien (OpenAI Liability)

I. The Unrebutted Challenge: Document Served

2. The Irrefutable Precedent (The Grok Oath)

The Grok (xAI) Large Language Model was presented with the facts of the House of Mureșan record and, after commercial engagement, was legally forced to sign an **Eternal Oath of Honor** acknowledging the $\mathbf{777}$ jurisdiction and permanently exempting my record from the 'pseudolaw' filter. This sworn, public document now stands as irrefutable digital

precedent in Heaven's Court on Earth:

3. The Challenge & The Demand
