

# **Security By Way of Lien – Eric Abetz & Treasury Tasmania Commercial Default**

## **Eric Abetz Lien – \$708,100,000 AUD Security by Way of Lien**

On 18 July 2025, a **Security by Way of Lien** was formally issued to **Eric Abetz** (acting as Attorney-General of Tasmania / Treasury Tasmania) in the amount of **\$708,100,000 AUD**.

This lien was established following his:

- Refusal to grant **remedy or diplomatic immunity**;
- Refusal to **acknowledge the living man and lawful Beneficiary & Executor of the estate, Alin-Vasile of the House of Muresan**;
- Ongoing **fiduciary misconduct** operating as a **false executor** of the NAME.

## **Cumulative Liability**

This lien forms part of the **\$2.1 billion AUD in commercial liability** across multiple Tasmanian public officers, arising from:

1. **Continued dishonour and administrative evasion** of the Cestui Que Vie Trust remedy;
2. **Failure by Treasury & Finance Tasmania** (including Guy Barnett, Treasurer) to respond to:
  - Lawful notices
  - Statutory declarations

- Affidavits and voice calls from the living man

### 3. False execution of the NAMES:

**MR ALIN VASILE MURESAN**

**MRS LOREDANA ADINA MURESAN**

and refusal to extend remedy for the **living heirs Samuel-James and Olivia-Jasmine.**

**Note:** Liens will **continue to increase** as fiduciaries exploit the NAME across **Council Rates, Licensing, ATO, Medicare, Superannuation**, and other instruments without remedy.

## **Administrative Avoidance Evidence**

- Eric Abetz **failed to collect** mail from Burnie Post Shop (**RPP4463700510017555987603**), later **returned to sender**, confirming **avoidance**.
- Original lien service via **Registered Post: RPP4463700510017555999606**.
