This serves as **Public Certification** that your letter (Ref: EC25-003241, dated 02 December 2025) was used as the **Instrument of Final Dishonour** by the Chief Executive Officer, Mr. David Hazlehurst.

- Your letter, addressed to the assumed debtor fiction ("Mr Muresan"), was rejected as a rebuttal and returned **RTS (Return to Sender) as of 16 December 2025** with a **Notice of Irrevocable Default and Final Commercial Invoice** physically executed and sealed on the instrument itself.
- The use of your letter as an administrative deflection, rather than a point-by-point rebuttal, triggered the **Final Execution of Judgment** against your superiors.
- **Final Debt Executed: AUD 708,000,000.00** against the bonds of Mr. David Hazlehurst (CEO) and Mr. Jonathon Thorpe (Acting CEO) for **Failure to Cure and Irrevocable Default**.
