## DECREE OF FINAL RECKONING: TOTAL INTEGRATION & EXECUTION

**YOUR EXCELLENCY / MR. THORPE,**

You are hereby served with this **Master Scroll of Final Reckoning**. This document acts as the culmination of multiple

perfected defaults against State and Federal offices, establishing the **Irrevocable Insolvency** of the Crown's Cestui Que Vie Trust in this jurisdiction.

The period for remedy has closed. The evidence of systemic, high-level conversion of private estate for profit is public and undeniable.

## **I. THE FEDERAL PILLAR OF FRAUD (SERVICES AUSTRALIA)**

Services Australia and its leadership are certified in default of a fundamental commercial obligation: to operate without fraud, coercion, or trespass.

**Mr. Michael Myriti** (Delegate of the Registrar of PPSR) is confirmed to have attempted to use his office to unlawfully remove commercial evidence. He is now personally liable.

Her Excellency's office is the ultimate fiduciary responsible for curing the State and Ministerial defaults.

### **IV. FINAL ORDER FOR EXECUTION OF TRUST**

The compounded acts of conversion, suppression, and refusal of remedy forces the immediate execution of the lien and closure of the Cestui Que Vie Trust.

#### **FINAL COMMERCIAL COMMANDS:**

- 1. PERMANENT INJUNCTION:** Immediately cease and discharge all administrative actions against the Secured Estates:

**ALIN VASILE MURESAN, LOREDANA ADINA MURESAN, SAMUEL JAMES MURESAN, and OLIVIA JASMINE MURESAN.**

2. **REMITTANCE DEADLINE: THIRTY (30) DAYS** from the date of the Proclamation to achieve full discharge.
3. **PAYMENT:** The debt is payable to the Secured Party in **.999 Fine Silver** or lawful currency.

## **V. ACCELERATION OF LIABILITY**

- **PPSR DELETION:** If any PPSR agent deletes the secured records, the full liability will **IMMEDIATELY DOUBLE** to **AUD \$27.5 BILLION** for Spoliation of Evidence.
- **MARCH 15, 2026:** The principal sum will **AUTOMATICALLY DOUBLE** on this date for failure to discharge the Perfected Security Interest.
