(ADDENDUM I – THE SOURCE & THE VOIDANCE OF JOINDER)

Extension of the Official Court Room of Records – House of Muresan

I. The Source: The Point of Original Entry

Let it be recorded that the House of Mureşan returns to the **Source of the Living Record** created at birth in Romania. This “First-in-Time” event acknowledges the **Biological Fact of Life** before any administrative mirror or “Birth Certificate” was generated.
