

Scroll of the Blood Seal House of Mureşan – Declarations & Decree

Declaration for Offsprings and Successors

I, **Alin-Vasile of the House of Mureşan**, living man, Beneficiary and Executor, publish this scroll for myself, my wife **Loredana-Adina**, and my offsprings – **Olivia Jasmine** and **Samuel James** – as heirs and successors of the living estate.

1. The Seal of Redemption

‡ We are redeemed – not by statute, not by commerce – but by the Blood of Christ Jesus, the Lamb of God.

‡ Our lives are already purchased, our bonds paid in full, and our freedom sealed in Heaven.

‡ Therefore, we speak and write on and for behalf of the Legal Name **“ALIN VASILE MURESAN”** and all members of the House of Mureşan. We have power over the Name, just as the Lord Almighty placed man in the Garden and said, *“Be fruitful and multiply,”* giving him dominion over every creature and every living thing God created.

‡ Thus, we – the living members of the House of Mureşan – hold power, authority, and power of attorney over the Legal Name and the LEGAL NAME in ALL CAPITAL LETTERS, as found on passports, driver licences, and government ID. Accordingly,

the NAME is subservient to us, for we are the true Beneficiaries and Executors over the Name and the original Creditors.
