

# **Security By Way of a Lien against employees of the STATE of Tasmania for commercial crimes. Crimes of these nature cannot go unpunished.**

A Security by Way of Lien, as used by the House of Muresan, is not a commercial loan security, but a lawful and spiritual instrument of notice and claim. It is used to secure restitution for harm, dishonour, and trespass against the living estate. ## □ Summary: HOM-JASON-MURRAY-LIEN-001

This Security by Way of a Lien and Affidavit of Fact was issued by **Alin-Vasile of the House of Mureşan**, acting as Beneficiary and Executor of the Living Estate, against **Jason Murray**, Chief Executive Officer of *Spirit Super / CareSuper Pty Ltd*.

It establishes lawful claim and notice of default following the merger of *Spirit Super* into *CareSuper* without consent, continued deductions from the NAME, and unjust enrichment through insurance charges without service or benefit.

The lien secures a value of **AUD \$708,000,000.00**, equivalent to **708 million troy ounces of fine silver**, as remedy for commercial dishonour, breach of fiduciary duty, and failure to close the account in honour.
