I. A MESSAGE OF LIGHT IN DARKNESS The **House of Muresan**, standing as a beacon of the Heavenly Kingdom on Earth, solemnly condemns the criminal acts and atrocities perpetrated at Bondi. We bring the light of truth to these dark times, not to hide behind tragedy, but to use the opportunity of the Governor-General's recent public statements to shed light on a profound administrative hypocrisy. II. THE NON-STATUTORY GLITCH (THE IDENTITY OF THE MOTH) The House of Muresan joins the facts: The **Tasmanian Gazette (via Allan Geoffrey)** has admitted our standing is **Non-Statutory** as he was instructed by his advisors. Simultaneously, at Bondi, the Governor-General Sam Mostyn confessed she has *"no government"* and is *"not political."* **The Question of Standing:** If she has no government and is non-political, who is she? If

she represents a Sovereign King, she is a Privateer. **Alin-Vasile**, as the **Attorney General for the House of Muresan**, represents a higher Sovereign Jurisdiction. We expose the fact that while the Governor-General claims a “Non-Statutory” status to evade her **\$13.7 Billion Commercial Liability**, she and her agents continue to attend Statutory Government meetings and enforce Statutory Legislations upon the Living Man.

III. THE BONDI CONFESSION (VIDEO EVIDENCE) On the public record [YouTube: G3KldDK0MhI], the Governor-General Sam Mostyn, acting as the “Silk Moth,” issued a stealth message of total deniability. She explicitly stated:

“I have no politics, I have no policies, I have no money to dispense, no programs to give... I am like a lightning rod.”

V. THE 1,000-YEAR THEFT (THE COMMERCIAL AUDIT)

While the Governor-General uses “Soft and Fuzzy” language at Bondi to claim she is “without money,” the math of the **Cestui Que Vie (CQV) Trust** extraction tells a different story:

- **The Living Man:** A common man laboring for **\$30/hr** for **4 hours a day** survives with zero net “substance” after basic costs are extracted by the corporate STATE.
- **The Silk Moth:** The Governor-General receives a total compensation package (including Salary, Palace maintenance, Staff, and Perks) **estimated at over \$1,200,000.00 per annum.**
- **The Accumulation Gap:** Based on this estimate, to save the value of just **one year** of the Governor’s “powerless” role, a living worker would have to labor for **over 1,000 years.**

The Burden of Proof: Should the Governor-General or the Crown dispute this commercial estimate, they are required to produce the **full, audited, wet-ink ledgers** of all expenditures and perks associated with the Office. Silence or failure to provide the actual figures shall be deemed as **tacit agreement** to the accuracy of this audit.

This is **Unjust Enrichment** and the parasitic consumption of the People's Credit by a **"Dry Trustee"** who simultaneously claims to have "no money to dispense." This record stands as the proof of the theft.

The Light of Truth does not stop at the Palace gates of Tasmania.
