

# Legal Fiction Rejected – Council Rates Letter Returned Unopened to Lachlan Kranz Liability

Published: 9 July 2025

Filed under: Living Record Journey, CQV Trust Rebuttal, Scrollwork Evidence

On 9 July 2025, a council rates notice issued by Huon Valley Council was [returned RTS \(Return to Sender\)](#) by the Living Man, unopened and unacknowledged, as it was addressed to the legal fiction: MR A V MURESAN. The envelope bore no wet-ink signature, no evidence of lawful contract, and contained a QR code, triggering presumption of digital identity tracking and CQV trust enforcement – which has already been lawfully rebutted and liened.
