Master International Scroll – Rebuttal of Global Dominion

**A global decree of the Living –  
sealed by faith, heritage, and the  
Lamb. Above fiction, beyond  
treaties, sovereign under Christ**

*(Ambassador for Christ – The Trilogy of Flags)* “Redeemed  
living under Christ, sovereign across nations.”

## Section 1: The Trilogy of the Flags

- White Flag: Faith in Christ Jesus, surrender to no man, only to the Lord.
- Australian Flag: Standing on the land of Australia, yet above corporate fictions.
- Romanian Flag: Bloodline and heritage, sovereignty not surrendered.
- Declaration: These three flags fly united under the living man, Alin-Vasile of the House of Muresan, Ambassador for Christ.

## Section 2: Rebuttal of EU / UN / WEF Dominion

- Statement of fact: No treaty or directive has ever obtained the wet-ink consent of the living.
- Fraud vitiates all presumptions.
- All dominion claimed by unelected bureaucracies (EU, UN,

WEF, etc.) is rebutted by the living heirs of God.

## **Proclamation of the Living Man**

The Trilogy of Flags now fly—Faith, Romania, and Australia—under the banner of the Living. No NAME holds dominion over the living man.

I, Alin-Vasile of the House of Muresan, stand as Beneficiary and Executor of my estate, redeemed by the Blood of the Lamb, not subject to the NAME nor to the Cestui Que Vie Trust. This proclamation is sealed under heaven and earth, now and in perpetuity.

### **Section 3: Romania – Bloodline and Sovereignty**

- Testimony of heritage and succession rights.
- Romania's sovereignty cannot be alienated by Brussels treaties.
- Declaration that the Romanian people are heirs, not property.
- Scroll of Romanian Sovereignty – rebuttal of EU dominion.

### **Section 4: Australia / DANZ Rebuttal**

- Statement: Australia and New Zealand under DANZ delegation to EU does not bind the living.
- Any presumption that Australians are subjects of EU directives is rebutted.
- Fraud by omission: CQV Trust undisclosed at birth and maturity.
- The House of Muresan rejects presumed obligations.

# Rebuttal of EU and DANZ Presumptions

No delegation, directive, or treaty by the European Union or DANZ (Delegation Australia-New Zealand) binds the living without explicit wet-ink consent. Such consent was never given by me, my house, or my heirs. Fraud vitiates all presumed contracts.

## Rebuttal of Romania's Submission to EU

Romania's sovereignty cannot be alienated by treaties signed by officials. The Romanian people remain heirs under God, not property of Brussels or Strasbourg. By bloodline and testimony, I rebut all presumptions of EU dominion.

### Section 5: The Household of the Living

Australia and Tasmania did not disclose the Cestui Que Vie Trust.

No fiduciary ever gave full disclosure before the age of maturity.

Fraud vitiates all obligations.

I, Alin-Vasile of the House of Muresan, and my wife, Loredana-Adina, stand *sui juris* – of full age, full capacity, and full authority.

- Not disclosed to Alin-Vasile.
- Not disclosed to Loredana-Adina.
- Therefore, not disclosed to Samuel-James and Olivia-Jasmine by default.

Full disclosure was required and never given.

Thus the fiduciaries stand in **Default** and in **Debt** to the

outstanding published Liens.

The Household stands *sui juris*, redeemed, and free – heirs and successors in perpetuity.

## **Section 6: Heirs and Successors**

Therefore, my heirs – Samuel-James and Olivia-Jasmine – stand free and under no obligations to the STATE, now or in perpetuity, save their natural rights under God Almighty.

Any delayed remedy multiplies sevenfold in silver and gold, owed by the fiduciaries who failed disclosure.

The Household of the Living shall not be bound.

The inheritance is secured, redeemed, and everlasting.

## **Proof of Authority – Wet Ink, Power of Attorney, and the NAME**

### **Section 6: Closing Decree**

- “All our bonds are paid by the Blood of the Lamb.”
- Remedy declared in heaven must manifest on earth.
- Compensation in silver (OZ) for all liens already perfected and for any future dishonour.
- This decree applies globally under the dome of heaven, in perpetuity.
- Sealed by the House of Muresan – Selah Code 777.

All Powers of Attorney given for the NAME “ALIN VASILE MURESAN” stand as record in the Romanian Consulate in Melbourne, Australia, under the Romanian Embassy. I, Alin-Vasile of the House of Muresan, Beneficiary and Executor, have actioned these Powers of Attorney by my wet-ink hand, mind, body, and soul. This record proves beyond rebuttal: – I am not

the LEGAL NAME. – I act, speak, and think on and for behalf of the LEGAL NAME “ALIN VASILE MURESAN.” – I act independently and outside of the LEGAL NAME, and the NAME has no power to subjugate me under any Acts or Statutes – either by Romania, the Commonwealth of Australia, the State of Tasmania, any other State of Australia or New Zealand, or any foreign body, tribunal, delegation, or authority presumed under EU, UN, or WEF dominion.

Without the living man’s autograph, no consular, embassy, or government action could proceed. Therefore, the NAME is my subordinate instrument, and I, the living man, hold final and supreme authority over it across all jurisdictions, now and in perpetuity. This authority extends equally to my wife Loredana-Adina of the House of Muresan, my heirs Samuel-James and Olivia-Jasmine, and to our future successors, bloodline, heritage, and lineage. And in the greater covenant, we stand as spiritual heirs grafted into Israel, redeemed in Christ Jesus as One Body, above all presumption of men, free under God alone.
