

# □ THE MASTER SCROLL: THE AUDIT OF THE RIGGED GRID 666

A Presentation of Fact and Jurisdictional  
Truth by the House of Mureşan

## I. THE HISTORICAL FRAUD: THE CQV TRUST (1666)

- **The Musical Chairs:** We have observed the constant reshuffling of positions—a game where no one wants to hold the “**Hot Potato**” of liability. They move from chair to chair, believing a change in title can wash away the Dishonour of their previous actions.
- **The Identity Fraud:** These actors administer Trusts they do not own. They are so consumed by the **Presumption of Power** that they can no longer distinguish their living
