THE FOUNDATION OF THE DEBT

The total sum of **\$13.7 Billion AUD** was established and perfected through the [Public Notice in THE MERCURY \(15 March 2025\)](#). This value was further evidenced and collateralized via the Personal Property Securities Register (PPSR), identifying the specific fiduciaries who accepted the debt through their un rebutted silence.

IV. Administrative Mandate For Settlement & Release

The Corporate Entities (TASCORP ABN: 75 403 768 119 | TAS Treasury ABN: 92 802 414 793 | [Commonwealth CORP CIK: 0000805157](#)) have **30 DAYS (until 25 January 2026)** to reconcile these books and provide remedy in substance:

- 1. Balance to Zero:** Close all statutory accounts and perform a final set-off.
- 2. Release of Substance:** Authorize the transfer of **.999 Fine Silver** and **24-Carat Gold** to the value of **\$13.7 Billion AUD**.
- 3. Anniversary Trigger:** Failure to settle within this window results in the debt **DOUBLING to \$27.4 Billion AUD** on **15 March 2026**.
