

Public Notices of Dishonour and Suppression by The House of Muresan Selah Code 777

I. The Rebuttal Of The Cestui Que Vie ACT

This document addresses the importance of **Public Notices of Dishonour and Suppression** in the context of legal proceedings and personal rights.

The **Cestui Que Vie Act 1666** was established to manage the estates of those “presumed dead” or “lost at sea.” All corporate fiduciaries and ABN-holding “Government” entities operate on the false presumption that the Man is a “vessel” lost in the jurisdiction of the sea. They are all under UCC Universal Commercial Code, unlike Selah Code 777 a Code for Life used by the Living to navigate the NAME.

- **The Rebuttal:** I have formally appeared in the **Court of Record** as the **Living Man—the Soul and Breath**. The presumption of “Death” is hereby **Rebutted**.
- **The Forensic Audit:** I utilize the **Peter Joseph Affidavit** to expose their **Deceptive Ways** and the internal fraud of the Bar Guild. It proves they operate under a **Falsity of Assumption**. This is a Public Document already served upon Body Polity and Stands unrebutted point by point. It is not something I created. The Peter Joseph Affidavit of Truth and Statement of Fact is used as a tool to serve to all feduciaries under the UCC and Body Polity, an unrebutted Affidavit Stands as Truth.
- **The Evidence of Life:** The **Live Birth Record** serves as my primary forensic proof of life. The “Vessel” has returned to the Land; the Trust is dissolved; I, the **Executor**, have returned to claim the Estate. I have

reclaimed all my Live Birth Records for my house of Muresan and the Body Polity of Tasmania has been informed Via this Court Room of Records. Wea the living man and woman son and daughter have returned from the Dead we have claimed our living Estate and Name from the National Debt of Tasmnia/Commonwealth of Australia State and Federal. Any fiduciaries using the Legal Name as found registered with the STATE are committing commercial Crimes, All Insurances and underwriters all Names associated with MURESAN umbrella have been reclaimed by the living and are null and VOID to the STATE they cannot be used for DEBT nor be used as securities for DEBT against the NAME. The NAMES are Used against you, the STATE with Security By way of Liens and commercial Charges against employees of the STATE issued against you by the House of Muresan.

II. THE ONION OF IDENTITY: ONE-WAY CONTRACT FRAUD AGAINST THE LEGAL NAME

The STATE operates on a **Two-Lane Highway** for themselves, while locking the **NAME** in a **One-Way, Closed-Loop Circle** namely: **DEBTOR, fine, extort, imprison, deny, and cancel.**

- **The Identity Onion:** What began as a competency license is now a complex ID integrated into layers of a “digital onion” used to extort the Living.
- **The Expiration Trap:** Without a STATE ID, the Living are unacknowledged and denied. They use the NAME on Paper without agreements and the living is ignored as non-existent. **No ID with Photo? No Service.** This is the **CQV TRUST 1666** principle: they treat me as “Expired” and “Dead” unless I pay to renew their fiction and even after payment of make belief legal fiscal the NAME is as dead entity ignoring All Rights, ignoring the Executor on and for behalf of the NAME the living man, for a NAME

cannot write has no brains no arms no legs no eyes and cannot talk and think. For this a living man needs to do and act. The STATE has created an artificial PERSON called the LEGAL NAME and this is under CQV TRUST under their Care until rebutted. The House of Muresan has taken charge over the NAMES Despite the denial of the STATE as they operate in presumption deception and undeniable deniability looped in their fiction of lies and body polity Politicians sworn in by the Governor General for their own Gain.

III. THE GUARD DOGS of Tasmania Police: THE HUONVILLE & TASMANIA POLICE WITNESS

The Police protect the **Body Polity**, not the people. They use batons, tasers, and physical force to arrest **NAMES on Paper**, ignoring the Living Soul to extract "Sweat Equity" through fraud, malfeasance misfeasance and acts of Terrorism. Although there are men and women with a soul once they put their badge on they become a thing a PERSON an artificial PERSON only seeing numbers \$\$ non performance and Acts and STATUES. When They Speak a man on the news and in their paper is ALL CAPITAL LETTERS ENTITY or a MR they will never admit the man is a living person a man with souls mind body and spirit, because to do so destroys their entire fiction of lies. So even their own people are forced and coerced to comply under Body Polity Acts and STATUES not to protect life but to deny rights and anyone outside of the controlled cage to be named Sovereign Citizens. For example we have seen this during COVID times people were coerced get vaccinated or quit, denied the right to work, get masked or get hurt! this was done in the Name of Safety and under Acts and Statues. These who see the light simply quit their Police Badge and walk off all who remain are SLAVES to a system under Acts and STATUES and Body Polity and corruption for the sake of a pay check.

- **The Huonville Saga:** Despite two **Statutory Declarations**—one rebutting the NAME as a **STRAW MAN** (identity stolen from birth) and another naming the **NOMINATED DRIVER**—the Police and Commissioner **Donna Adams** remained silent. When asked in the station, “*Are you this Person?*” I said **NO**. I explained I am a man and that **PERSON** represents an artificial entity.
- **The Joinder by Paper:** Inspector **Kathy Bennet** never faced me as a man; she instead attempted **Joinder by stealth** by sending letters to Mr Alin MURESAN, ignoring my rebuttal of the fines via Service Tasmania and ignoring Peter Joseph Affidavit the automatic system simply spat out letters pointing to seat belt not being worn. **WHY?** Because the system is locked in CQV Trust with only the Joiner Hi Alin and then followed by the all capitals MURESAN. When the man acknowledges such letters he becomes one with the **DEAD** and the system sees the **DEAD** and someone as acted as the **DEAD** thing a ward of the **STATE** property sold or traded cancelled and denied access because Acts and Statutes says so. Acts and Statutes are for Body Polity Actors who created them to be used against them not the sovereign people.
- **The “Get Out” Protocol:** The Police Officers at the **Huonville Police Station**, frustrated by a Living Man they could not process, nor identify him as a living man demanded: “*GET OUT!*” A living man has no place in a Police Station, as their jurisdiction is strictly for **PERSONS** (fictions).
- **The \$425M Lien:** Upon asking if they received the Public Notice regarding a **\$425,000,000.00 Lien** against **Wayne Johnson (MPES)**, the officer yelled: “*GET OUT! LEAVE!*” An aggressive man dressed in fiction, unable to handle the reality of a Security Interest that their MPES Office is in Default and Wayne Johnson Director for Monetary Penalties Enforcement Service has no credibility and in Default to Mr Alin Muresan and the House of Muresan.

III. SUPPRESSION OF EVIDENCE: TASMANIA POLICE BLOCKING OF SERVICE AFTER THE MERCURY PUBLIC NOTICE

□□ VI. THE FRAUD IN PLAIN SIGHT: THEFT OF NATURAL RIGHTS BY SERVICE TASMANIA

The Forensic Discovery: Service Tasmania has confirmed the extraction of **3 demerit points** from the account of the **NAME: MURESAN ALIN VASILE**. This act was performed against a living man for a “crime” he did not commit, using a vehicle registered to **ALIN V. MURESAN**—a sub-account of the **Cestui Que Vie 1666 Trust**.

The Breach of Trust:

Trespass on Reservation: Despite the living man, **Alin-Vasile**, reserving all rights pursuant to **UCC 1-308** on the License, the STATE chose to ignore the standing of the Living Man.

Bypassing the Executor: The STATE deliberately bypassed the **Executor (alin-vasile)** to interact with the **Registered Operator (ALIN V. MURESAN)**.

False Executorship: By unilaterally issuing these points and registration documents, the STATE is acting as a **False Executor** over the **House of Mureșan**, attempting to manage an estate they do not own.

The Verdict: This is **One-Way Contract Fraud**. A “Registered Operator” is a statutory servant created by the STATE; the **Executor** is the Master of the Asset. The STATE is attempting to extract commercial value (points/fines) by enslaving the

name to a debt the man never signed for.

NOTICE: The House of Mureşan has a perfected **Security Interest** in the NAME. Any unauthorized use of the NAME or extraction of value from it constitutes a commercial lien against the agents involved.

VI. THE TEL-A-VISION AND THE ACADEMY

The STATE forces worship of the **Beast System** through the **ALL CAPS LEGAL NAME**, the **TEL-A-VISION** (Television), mass media, and internet mind control, all anchored in the **Cestui Que Vie Act 1666**. Most are marked already! If you want the sheep to follow, tell them a **VISION**, tell them a **LIE**. When this deception fails to secure consent, they bring the **Guard DOGS**.

The term **“Guard Dogs”** is not an insult to the POLICE, but a precise forensic description of how they operate. They do not function for the living man or the life thereof; instead, they operate as a perimeter for the **BODY POLITY**, protecting politicians, Acts, Statutes, Actors, and Fiction. They are used specifically to fine and extort the **Legal Name**.

They exist as the bridge between **Life, Death, and Fiction**:

- **Life and Death:** Because they possess the physical power to kill and carry weapons in the natural world.
- **Fiction:** Because they are bound by corporate code and commit commercial crimes against the Living Soul.

Despite “seeing” in the Natural—knowing they are speaking to a man of flesh and blood—they choose to ignore the Living to serve the Fiction.

I use the term **“Sovereign Citizen”** because it is the forensic label used by the **Police Academy** to train officers to ignore the Law. I cite the following **Public Admissions** of the STATE

as proof of this institutional deception:

National Counter-Terrorism Plan: This public document links jurisdictional challenges directly to security risks, authorizing “Guard Dogs” to bypass Lawful process and use immediate physical coercion (Batons and Tasers).

ASIO Public Threat Assessments: The Australian Security Intelligence Organisation (ASIO) explicitly categorizes the “reclaiming of Sovereign Living Souls” and “Strawman” arguments as **Ideologically Motivated Violent Extremism (IMVE)**. This provides the “Academy” with the administrative excuse to treat the Truth as a “Terrorist Threat.”

The Judicial Commission “Bench Books”: Publicly available manuals (such as the *Equality before the Law Bench Book*) provide “scripts” for judges to ignore the **NAME vs. MAN** distinction.
