## **THE AMENDED OPERATIONAL DECREE: IN THE WORLD, NOT OF IT**

### **VII. THE EXECUTIVE RESERVATION OF OPERATIONAL RIGHTS**

The **House of Muresan** hereby records that while the Living Souls have vacated the 1666 Labyrinth, we remain "In the World, but Not of It."

- **The Limited Interaction:** We reserve all rights **Sui Juris** for the benefit of the Living and the Executors: **alin-vasile, loredana-adina, olivia-jasmine, and samuel-james.**
- **The Necessity of the Tool:** For necessary physical transactions—including but not limited to the purchase of vehicles, equipment, or services—the use of the NAMES is permitted **only** as a dead tool of the Executor.
