EXECUTIVE NOTICE: *"He who comes to equity must come with clean hands."* I, Alin-Vasile, Executor of the House of Muresan, having performed a forensic audit of this Record of Standing, hereby perfect the chronology of the Living Souls. Transcription errors (e.g., 'lank' to 'Land') have been rectified. The arrival age of Loredana-Adina in 1989 is corrected from 9 to **11** to reflect the absolute truth of our

history. These corrections signify the **Spirit of Truth** that governs this Private Court. The substance of the Genesis remains unshakable: We were children of the Land, minors without capacity, captured by a system we now formally exit. **Selah.**

I. THE HISTORICAL ARRIVAL in to the land known as Australia (Years 1987 & 1989)

Be it recorded for the Public Record that the foundations of the House of Muresan were established upon this soil as **Foreign National Estates** under the protection of the Romanian Sovereign:

- **ALIN-VASILE (Year 1987):** Entered the territory known as Australia at age **12**, traveling under the authority of his **Father's Romanian Passport**.
 - **LOREDANA-ADINA (Year 1989):** Entered the territory known as Australia at age **11**, traveling under the authority of her **Mother's Romanian Passport**.
 - **The Minority Capture:** At **age 11** and **age 12**, we were **Minors** with no legal capacity to contract. The STATE utilized our parents as **"Informants"** to register us into corporate registries without disclosure. This **"In-forming"** was a unilateral act of the STATE to capture our future labor and estate into the [Cestui Que Vie 1666 Trust](#).
- The Reclamation:** By securing the **Certificat constatator de nastere** for ALIN VASILE MURESAN, he is now fully restored from a **"captured 12-year-old minor"** to the **Living Man** of the House of Muresan, standing under the protection of the **Executive Power of Attorney**.
- **The Informant Trap:** The STATE utilized our parents—legally demoted to the status of **"Informants"**—to **"In-form"** (register) us into corporate registries as minors. This occurred without full disclosure of the

[Cestui Que Vie Act 1666](#) or the commercial nature of the “Australian Citizen” fiction.

- **Absence of Consent:** At no point in our adult lives have we applied for Australian Citizenship by way of wet-ink signature, consensual contract, or autograph with agreement of the minds and full disclosure between the parties.

II. THE HUONVILLE AUSTRALIA POST OFFICE DISCLOSURE: THE 99-YEAR TRUST FRAUD

In 2025, to recover the Primary Title of the House, the Living Man performed an administrative audit at the Huonville Australia Post Office, witnessing the following **De Son Tort** (trespasser) conduct:

- **The 99-Year Term:** The STATE’s own documentation disclosed that the “renewal” carried a term of **99 years**. This is the hallmark of a **Long-Term Testamentary Trust**, proving the “Passport” is a vessel for the monetization of the Living Man’s life force for a century.
- **The \$400 Extortion:** I was charged over **\$400** for a purported “10-year renewal” of an instrument that the STATE’s own form admitted was a 99-year capture.
- **The Burial of Rights:** The clerk prohibited the autograph of “**All Rights Reserved.**” Under telephonic guidance from the Passport Office, the clerk **glued the “Reserved” photo face-down**, ritualistically attempting to bury the Man’s current standing.
- **The Forced Signature:** The STATE coerced the use of a **10-year-old signature**, effectively forcing the Man to impersonate a past version of himself to satisfy a corporate registry. When I informed the officer of this fraud, she threatened to “**tear the application.**”

III. THE BRIDGE OF RECLAMATION: THE ROOT OF TITLE

Despite the STATE's subsequent issuance of the instrument using a forced, outdated signature—which serves as an official Estoppel—the House of Muresan has bypassed the corporate gatekeepers to secure the **ROOT OF TITLE**:

The Shift to Executive Power: Because the STATE Australia Post in Huonville who acted as an Agent for [DFAT](#) whom refused to accept a signature with “All Rights Reserved” in Huonville, they defaulted as Trustees. I have bypassed their “privilege” system to reclaim the **Sovereign Birthright** for my entire House.

- LOREDANA ADINA MURESAN
- OLIVIA JASMINE MURESAN
- SAMUEL JAMES MURESAN

The Primary Evidence: Namely, the **Certificat constatator de nastere MURESAN ALIN VASILE (nascut viu)**. This record, stating “nascut viu” (**Born Alive**), constitutes the First and Highest Evidence of Life, predating and superseding all derivative corporate registries.

The Sovereign Umbrella (Loredana-Adina): We recognize the 1989 administrative capture of Loredana-Adina at **11 years of age** as a “Void” act, performed while she was a minor without capacity. Due to the displacement of family connections in Romania, I, as Husband and Executor, have anchored her standing to my **Primary Root of Title**. She is reclaimed from the corporate “subject” status and placed under the **Irrevocable Power of Attorney** of the House of Muresan and now

stands as EXECUTOR in her own right for LOREDANA ADINA MURESAN.
