BE IT KNOWN AND RECORDED: I, **alin-vasile:** and I, **loredana-adina:** of the House of Muresan—living man and living woman by natural descent and of sound mind—on and for behalf of **MURESAN ALIN VASILE** and **MURESAN LOREDANA ADINA**, hereby declare and record an **ABSOLUTE ATTACHMENT** and a **Senior Security Interest** in all property, assets, **BONDS**, Securities, Wages, Benefits, Salaries, and Pensions of **ROBERT MANNING**, in the position of Recorder of Titles at the Land Titles Office Tasmania, and upon the **ABN 58 259 330 901**, for Administrative Piracy, Personage, and Breach of Fiduciary Duty.

## □ TERMINATION OF STATE BENEFIT & RECLAMATION OF THE ROOT

## ☐☐ SUMMARY OF ADMINISTRATIVE FINDINGS

### RECORD OF DEFAULT & VESTED LIABILITY

1. **LACK OF AUTHORITY:** The Debtor, **ROBERT MANNING**, has never provided material evidence of a valid Power of Attorney over the House of Muresan or the physical asset **Volume 72979 Folio 1**. The **Blue Certificate Title in Fee Simple** remains in the physical hands of the living.
2. **WILLFUL BREACH:** As a senior lawyer with over 30 years’ experience, the Debtor’s attempt to “convert” the record is evidence of **Malice Aforethought**.
3. **TACTICAL DEFAULT:** On 30 March 2026, the Debtor accepted Actual Notice. The issuance of a [non-responsive electronic template](#) (EXHIBIT A) constitutes a formal confession of intent to commit Administrative Piracy.
4. **VESTED SILVER LIABILITY:** Pursuant to Point 6 of the

unrebutted Mandate ([RPP: 44 63800 09400 61704 63603](#)), the Debtor has agreed to a daily penalty of **10,000 oz of .999 Fine Silver** for the intent to “Mend, Merge, or Delete” the physical record. This liability has accrued daily since **07 April 2026** and is attached to the Debtor’s Public Official Bond.

These entities and CQV Trusts are removed from the National Debt of Tasmania and the Commonwealth of Australia as per the [Omega Record](#). All “implied consent” to [Digital ID, QR Codes, or Quantum tokenization is Terminated Ab Initio.](#)
