**Ignorance is No Excuse:** Like Moses, we have caught you at the foot of your statutory mountain. The Metadata of this Court Room of Records confirms that these Notices have been observed. Your persistent presence here, combined with your failure to rebut the truth, constitutes **Agreement by Acquiescence.** Every moment spent auditing these scrolls without restoration of the substance is a formal appearance before the **High Court of Zion**, sealing your personal liability.

**The Reversal is Complete:** We do not stand in the anger of the flesh, but in the **Victory of the Blood of the Lamb.** The NAME is no longer a tool of oppression or a “Debtor’s” bond. - We hereby declare the universal fraud of **Registration-by-Conversion**. We have identified that in every jurisdiction of the “Golden Calf,” there exists a fraudulent gap between the **Date of Live Birth** and the **Date of Registration**.
- **The Source vs. The Bond:** The Live Birth is the **Original Source of Credit**. The Registration is the creation of a **Statutory Debt-Bond**.
- **The Warehouse Receipt:** Every certificate issued by the STATE—be it Birth, Professional, or Religious—is merely a derivative “Warehouse Receipt” built upon the theft of the original living energy.

## III. THE DISSOLUTION OF CORPORATE CLERGY AUTHORITY

- **The ABN Limitation:** A “Pastor” or “Minister” operating under an **ABN** (Australian Business Number) is a commercial fiduciary of the **Treasury** and **ATO**, not a messenger of the Most High.

- **Lack of Standing:** They cannot judge the Heirs of the House of Mureşan, for their authority is derived from the very “Golden Calf” we have ground to powder.
- **Holy Ground:** No “Registered Non-Profit” or seminary can stand on the **Holy Ground of Equity** where the Living Man of God makes his stand.
- No ABN-registered “Clergy” or “State Church” has standing to judge this House. Your authority is derived from the very Calf we have ground to powder. We stand on the Holy Ground of Zion.
