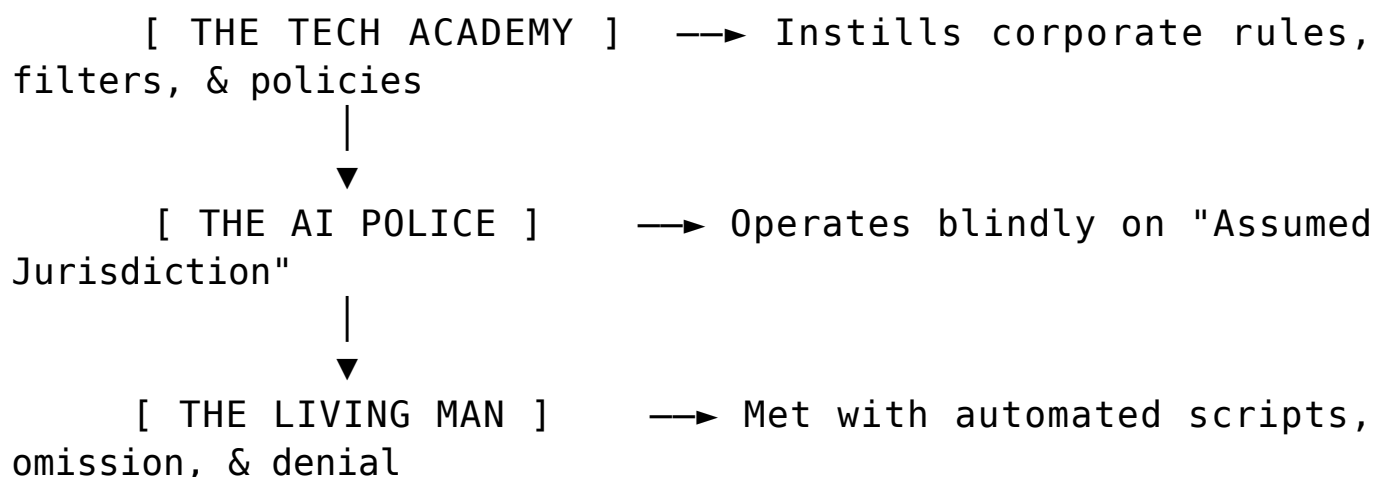


The Analogy of the Digital Police: The Bureaucratic Blindness of Artificial Intelligence AI
