- **THE NAME (The Account/Vessel/Legal Name):** The string of characters known as **ALIN MURESAN** is a corporate utility tool, a trust account, and a **“Vessel in Commerce”** once a VESSEL LOST at SEA now reclaimed by the Attorney-General Alin-Vasile of the House of Muresan. It is a Tool, not a Life. - **COLOR OF LAW VARIATIONS:** Be it known that this Vessel includes any and all variations used by the Fiduciaries under “color of Law,” including but not limited to: **MURESAN Alin, MURESAN ALIN, MURESAN A, A. MURESAN, A.V.MURESAN, Mr. A Muresan, Mrs. L A Muresan,** and or any other combination of upper/lower case, dots, or abbreviations and not limmited to (e.g., on Vehicle Registrations or Superannuation accounts, tates notices, fines,medicare which we have surrendered RTS to you,passport,driver licence etc).
- **THE USURPATION:** Because of a lack of transparency, the STATE operates as False Executors over the Legal Name in every matter in a statutory box for corporate benefit

which is an Act of fraud, malfeasance, and an act of Commercial Terrorism. They assume ownership over the NAME and assumptions of a PARENT and WARD Relationship and Presumption of JOINER and lack of maturity to govern one self. This presumption is shattered by the Blood of the Lamb Jesus Christ of Nazareth and the blood of the living through the veins breath and soul and mind and the Testimony of Jesus through our mouth's and written word upon our hearts and ability to Reason and write and think, Sui Juris reclaiming all rights. - **THE PILOT VS. THE PIRATE:** We are boarding these Vessels as **Pilots in Command** on the sea of commerce. When a PILOT Boards a VESSEL under Sea Merchant under any FLAG that PILOT Takes absolute control of the VESSEL and the VESSEL is now under the Jurisdiction of the PILOT to charter the VESSEL as he Knows best, this is to prevent damage to the VESSEL and hitting a Rock and Navigating it under his COMMAND. ## **II. THE CONFESSION OF THE STATE (ADMINISTRATIVE DEFAULT)**

**BE IT REMEMBERED** that the Treasury and Finance in Tasmania and the Tasmanian Gazette have declared the living man to be **OUTSIDE** their fiction of **STATUTORY** Rule.

- **THE MASTER KEY:** By classifying our records as “**Non-Statutory,**” they have handed the living man the Master Key. They want the Name, but they refuse to deal with the **Living Man**.
- **THE BROKEN TRUST:** Your silence and ignorance—which breaks the sound barrier of the unseen veil—has been shattered by the [Mercury \(March 15, 2025\)](#) and the [Omega Record](#).

## **III. THE DOCTRINE OF CONDITIONAL**

# APPEARANCE

Whenever the Name is called in the Public Labyrinth (Police, Courts, Banks), the following truths apply:

1. **IDENTITY VS. IDENTIFICATION:** The Name is used for Identification (to find the file), never for the living man to become a file.
2. **AGENCY:** The Man is the **Executor**; the Name is the **Utility Account**. The Executor is never liable for the debts of the Utility. The STATE is in Default and the House of Muresan is the [Receiver](#).
3. **DURESS:** Any requirement to “be” the NAME is a **Trespass** accepted only under **Duress and Necessity**, with all Rights Reserved. Any presumption ALIN VASILE MURESAN is a VESSEL without a PILOT shall be charged in .999 silver for the Attorney-General of the House of Muresan is the Pilot in command over the VESSEL’S NAMES. The STATE is now paying rent for the NAMES in .999 silver oz and 24 carat Gold.

## III(a). THE SEMANTIC CLARITY DECREE: SHATTERING THE AMBIGUITY

**THE CAPACITY OVERRIDE:** Be it known to all Scribes and Fiduciaries that the **Semantic Ambiguity** of the Labyrinth is hereby **SHATTERED**. The House of Muresan recognizes the “NAME” only as a **Vessel of Necessity**.

- **UNIVERSAL STANDING:** Any and all use of the **NAME** (ALIN MURESAN or its variations) by the Living Man in the public square—whether by signature, presentation of plastic credentials, or verbal acknowledgement—is performed **strictly and exclusively** in the capacity of **Executor and Secured Party** and Secured by .999 silver Selah Code 777 and the Blood of the Lamb.
- Any Claims naming this house of Muresan a SOVREIGN

CITIZEN will backfire by the forging FIRE of the CAST in silver and Gold against the Perpetrator. The Perpetrator shall be CAST in forever CAST of silver and gold owed to the House of Muresan.

- **REJECTION OF FICTION:** At no time, under any circumstances, does the Living Man “become” the Fiction or the Ward of the STATE.
