Jesus Christ, the Prince of Peace, is the only One who can give rest. Jesus Christ is the ultimate Selah and Sabbath over every matter and circumstance that may present itself as out of your control.

To overcome the Beast system and its deception, you must be rooted in Jesus Christ of Nazareth. You must be Born Again and filled with His Holy Spirit so that you may not be deceived. You, the living soul, are not the LEGAL NAME. You have a Name your mother and father gave you after birth; however, that name your mother knows you by is now presumed to be the property of the STATE. Thus, the system views you as a thing, a ward of the STATE—also known as legalized slavery and the trafficking of human flesh for taxes, fines, and full control over every area of your life.

The Beast System will try to enforce itself and attach itself to the LEGAL NAME. For example: What is required to attain an ID? The beast asks at least three questions: *What is your Name? What is your Date of Birth? What is your Address?*

The answers to these questions will match the *Cestui Que Vie Act 1666* ALL-CAPITAL LEGAL NAME on your Driver's License, Medicare Card, Passport, etc. These NAMES are registered based on your Live Birth Record, and the Birth Certificate was issued with a new registration created *after* the live birth

record. These three forensic data points—Name, DOB, and Address—are the key identifiers the Labyrinth uses to locate the paper-based, State-created birth trust account, forcing a digital joinder that seamlessly migrates the old paper trap into the new QR-code matrix.

Based on the *Cestui Que Vie Act 1666* principle, the Fiduciaries (the STATE, which registered the NAME and ID legal document) treat the living soul as “lost at sea,” operating under the presumption that “Reversioners cannot find out whether they are alive or dead.” By this presumption, you are ignored. Because the STATE cannot speak to the living, the LEGAL FICTION known as the STATUTORY is dictated by Acts and Statutes that control what the LEGAL NAME can and cannot do, and what obligations and demands are placed upon it.

You only have the *presumption* of rights, known as privileges, licenses, registrations, and certificates—all instruments created and registered by the STATE. Once the Creditor gives their signature or consent for a service, product, or necessity, that freshly acquired consent is transferred into a closed 360-degree loop of Acts and Statutes that limit benefits and dictate what the NAME must do or pay to function. It is like a bad shepherd fleecing the sheep. The STATE does not provide full disclosure between the parties and operates the NAME as False Executors (*Executor De Son Tort*).

Let’s take the Driver’s License, for example. In order to

drive, one must have a license. If the LEGAL NAME does not have that license, the LEGAL NAME is penalized, threatened, and even imprisoned. You may ask, *how can a legal name on a piece of plastic be imprisoned?* An all-capital NAME is attached to the living via SURETY, and the STATE does not separate the dead from the living. In other words, the STATE makes no distinction between John (the living man who acts as Beneficiary and Executor for the Legal Name) and JOHN DOE SMITH (the legal fiction). The system only sees JOHN DOE SMITH. Even in cases where the living man or woman is innocent, JOHN DOE SMITH is penalized and incarcerated upon your identification as the LEGAL NAME, depending on the allegations and the Acts and Statutes regarding that allegation. If you claim you are not the LEGAL NAME, the system forces you to identify. The moment you identify with the SURNAME, full name, and date of birth, you create Joinder to the *Cestui Que Vie Act 1666*.

“The *Cestui Que Vie Act 1666* can easily be found in the UK public legislation archives for those willing to look. Although the system will not openly acknowledge its modern application, my own research has revealed the truth through observation: the STATE absolutely treats your Legal Name as if you are “lost at sea” and cannot be found. You can see this clearly by the way the system interacts with it. It operates as a one-way highway—the STATE dictates, demands, and assumes authority over the NAME, but it completely refuses to hear or acknowledge the living, breathing soul standing behind it.”

This is not you, the living, anymore; it is the Legal Fiction Persona in a fictional world. "5 I am the vine, you are the branches. He who abides in Me, and I in him, bears much fruit; for without Me you can do nothing. 6 If anyone does not abide in Me, he is cast out as a branch and is withered; and they gather them and throw them into the fire, and they are burned."

Knowing who you are—that you are more than the NAME, more than the Legal NAME, and that your uniquely made mind, body, and soul are wonderful—is imperative. The Beast system only sees a LEGAL NAME, one it controls, demanding worship and submission to Acts and Statutes in order to receive any benefits in this world. In due course, they will fully introduce CBDC, DIGITAL IDs, and QR CODES.
