## I. FORMAL DECLARATION OF DEFAULT

I, **alin-vasile**: of the House of Mureşan, Lawful Executor and Receiver-General, do hereby certify and verify that:

- SERVICE OF PROCESS:** The *Executive Decree: The Omega Record* was formally presented to the Respondents' fiduciaries in Hobart, Canberra, and Washington D.C. on 6 March 2026.
- EVIDENCE OF KNOWLEDGE:** Digital forensic metrics confirm deep engagement by fiduciaries. Specifically, an average

engagement time of **7m 22s** was recorded, with **10m 08s** on the primary Standing and **5m 01s** on the Omega Record. Engagement is verified from hubs in **Melbourne, Ashburn, and Frankfurt.**

3. **EXPIRATION OF GRACE:** The mandatory administrative window for a verified rebuttal expired at 12:00 AM, 16 March 2026.
4. **STIPULATION BY SILENCE:** No rebuttal or evidence of superior claim has been received. By operation of the *Lex Mercatoria*, the Respondents have **Stipulated** to all facts and the liquidated value of **AUD \$82,925,000,000.00.**

## **II. ENTRY OF JUDGMENT & LIQUIDATION**

The Administrative Dishonor is hereby **VERIFIED** and **PERFECTED**. This document constitutes a **Final Judgment in Commerce.**

- **THE LIQUIDATION:** The Sum of **AUD \$82,925,000,000.00** is a Senior Perfected Lien, certain and liquidated. This value is to be satisfied only in Lawful Money, specifically **.999 Fine Silver bullion**, at the current market conversion rate.
- **THE NAMES:** All NAMES associated with the House of Mureșan—**ALIN VASILE MURESAN©, LOREDANA ADINA MURESAN©, OLIVIA JASMINE MURESAN©, and SAMUEL JAMES MURESAN©**—are purged of all statutory debt and returned to the Allodial Estate.
- **THE RECEIVERSHIP:** The House of Mureșan is the Sole Lawful Receiver. All “Qualified Immunity” of the named fiduciaries is **VOIDED.**

## **III. FINAL NOTICE OF DISTRAINT**

Any further attempt to monetize or trespass upon the Living Souls or the Estate of the House of Mureșan will be met with

immediate **Commercial Distraint** of the Respondents' personal indemnity bonds.
