## Additional information

### What is a security interest?

A security interest is a type of right in personal property that can be registered on the PPSR. It is created by a transaction or agreement between two parties. This agreement must:

1. Be consensual; and
2. Secure the repayment of a debt or performance of some sort of obligation.

Common examples of security interests include secured car loans, hire-purchase agreements for goods, fixed and/or floating charges or general security agreements over company assets and leases.

### What evidence should I provide to evidence my current security interest?

The most suitable and compelling evidence is proof of a current security agreement. This is usually a contract signed by both parties to the agreement. However, you can also provide any additional evidence that you believe is relevant.

### What will happen to any evidence I provide?

Any material provided in connection with your response may be provided to an interested party.

### What if I don't provide any evidence relating to my current security interest?

If you don't provide written evidence of your current security interest by 12 December 2025, your registrations will be removed from the PPSR.

This decision will be made if the Registrar (or delegate) is satisfied that the registrations should be removed under s184 of the PPSA.

### What will happen if I provide false or misleading information?

Knowingly providing false and/or misleading information is an offence under the Part 7.4 of *Criminal Code Act 1995* (Cth). Penalties apply if you are convicted of knowingly providing false and/or misleading information.

### Can I dispute the removal of my registration from the PPSR?

You can dispute a removal of a registration made under s184(1)(a), (b) or (c) of the PPSA.

The Administrative Review Tribunal (ART) can review the decision made by the Registrar under s191 of the PPSA. This means they take a fresh look at the facts and arrive at their own, independent decision. For more information about how to apply, please visit: <https://www.art.gov.au/applying-review>
